SEC. 13 - REGULATIONS FOR SPECIFIC SIGN TYPES: TEMPORARY SIGNS

(f) Banner *signs*. Each retail business is permitted one temporary banner which shall not exceed 32 square feet of copy area, and shall be attached to the building wall; for one continuous seven-day period, not to exceed two such periods in any calendar year. The banner shall be completely secured to a building or a sturdy frame on at least two opposite sides or at all four corners to prevent loose portions of the banner from moving in the wind to the extent that it would become a prohibited "animated sign" (see subsection 11(a) [of this article]). Such sign may bear any noncommercial message or a message related to goods, products, or services offered on the premises.

VIOLATIONS OF THE ABOVE MAY RESULT IN AN ISSUANCE OF A STOP WORK ORDER.
